BIPARTISAN BILLS WOULD PROTECT AMERICA'S COASTS, OCEANS AND MARINE LIFE FROM OFFSHORE DRILLING EXPANSION

Members of Congress seek to block drilling off Eastern Gulf, Atlantic, Pacific

WASHINGTON, D.C. – June 19, 2019 – The House Natural Resources Committee <u>held a markup</u> today on bills that would permanently ban offshore drilling off large swaths of the nation's coasts. The bills by Rep. Francis Rooney (R-FL) and Rep. Joe Cunningham (D-SC) (H.R. 205 and H.R. 1941), would permanently ban offshore drilling off Florida's Gulf Coast, and Atlantic and Pacific Coasts respectively. There is widespread bipartisan opposition to expanded offshore drilling from every East and West Coast governor, 2,200 elected officials across the political spectrum, more than 360 municipalities, 47,000 businesses and 500,000 fishing families.

12 leading national and local organizations offered the following statement in response:

"These measures are a key step toward halting the expansion of offshore oil and gas drilling, a dangerous practice that threatens our nation's coastal communities, oceans, national parks, marine life and climate. We cannot afford another catastrophic oil spill on our shores just to pad the pockets of the oil and gas industry. That's why Governors from coast to coast, thousands of elected officials, local businesses and environmental organizations oppose expanded offshore drilling activities. Leadership by bill sponsors Rep. Cunningham and Rep. Rooney would protect our coasts and communities, and we urge the full House to take up these bills for a vote as quickly as possible."
